Nature of Acquisition: Permanent
Purpose of Acquisition: Veterinary Hospital & MCD Store at Circular Road Shahdara, Delhi
Village: Chandrawali @ Shahdara.

These are the proceedings u/s 11A of LA Act 1894 for the acquisition of land measuring 0 Bigha 10 Biswa 10 Biswansi situated in Village Chandrawali. The land was notified u/s 4 of the land Acquisition Act vide notification No.F8 (17)/04/L&B/LA/12691 dated 18/1/06 for public purpose namely Veterinary Hospital & MCD Store at Circular road, Shahdara, Delhi. Objections u/s 5-A of L A. Act have been received and heard. The declaration u/s 6 of the L.A. Act. 1894 was issued by the N.C.T. of Delhi vide notification No.F.8 (17)/04/L&B/LA/3913 dated 15/6/06 for aforesaid area.

Notices u/s 9(1) & 10(1) of the Land Acquisition Act were issued to all interested persons. The claims filed by them are discussed herewith under the heading "Claims & Evidence".

MEASUREMENT & TRUE AREA

The Land Acquisition field staff carried out the necessary measurement of the land at the site and its verification was also made from the revenue record of the village Chandrawali. The total area of land for acquisition measuring 0 Bigha 10 Biswa 10 Biswansi was found to be correct. The details of the area under present acquisition are given below :
